1. Situation. To promulgate to subordinate commands/sections the quarterly checklist of effective Depot directives.

2. Mission. To publish a checklist of current Depot directives and to provide ordering instructions.

3. Execution

a. Commander's Intent and Concept of Operations

(1) Commander's Intent. To provide a listing of current Depot Directives (enclosures (1) and (2)) and to reduce the requirement to hold paper copies of Depot directives. This Bulletin and the reference will assist in determining which Depot directives should be held.

(2) Concept of Operations

(a) The reference will be used to determine where directives are routed based on the distribution code.

(b) Commands will further determine directives requirements based on a review of this Bulletin.

(c) Commands are no longer required to hold paper copies of Depot directives if an electronic version is available. Depot directives except those specifically identified in this Bulletin, are available for print or viewing at the following website:

(d) If a requirement exists to hold a directive not listed electronically on the above website, enclosure (3) will be utilized to order the directive from this Headquarters.

b. Subordinate Element Missions. COs, the heads of each activity, and the offices listed in the Distribution List will review this Bulletin and determine:

(1) Which directives they currently hold that can be eliminated due to the electronic copy being available.

(2) Which directives they currently hold that are canceled and can be destroyed.

(3) Which directives they require, that they do not hold and are not available in electronic format. See enclosure (2).


